

This non-transferable permit expires on 4/27/2014.

- It is the responsibility of the applicant/property owner to obtain all necessary approvals/permits from state, federal, and other agencies that have regulatory authority.
- Permit fee refunds of 80% may be granted if work has not commenced and a written request with original receipt or a copy is postmarked within 180 days of the Issue date.
- Your permit will expire if you have not started the work within 180 DAYS after the date the permit is issued. If you are unable to begin work and do not call for and receive an inspection within this time period, the permit will automatically expire.
- If you know that you will not be able to begin construction you may request one 180 day extension. You must make the request for extension BEFORE the permit expires.
- Once the work has begun you may not abandon the work (stop working) for more than 180 days. If you do not request and receive an inspection within 180 days of the date the permit is issued or since the date of the last inspection the permit will automatically expire. If you are not ready for the next required inspection you may schedule a progress inspection.
- If you know that you will have to suspend work for more than the 180 days you must contact the Building Division to review available options.
- No permit will be extended beyond five (5) years from the date the permit was issued. At the end of five (5) years you will be required to obtain a permit for the work remaining.
- In the event of cancellation of this building permit, Traffic Impact Fees (TIF) may not be available for refund if they have been expended or encumbered in accordance with Pierce County Code 4A.10.110.F.

Prior to performing any renovation or demolition work, Puget Sound Clean Air Agency (Clean Air Agency) and Washington Department of Labor and Industries (L & I) regulations require an asbestos survey be performed to determine whether there are asbestos--containing materials in the work area or structure. The asbestos survey must be conducted by an EPA certified (AHERA) Building Inspector (except renovation of single family residences).
